


3. Aims and Objectives:


3. Membership:


Any person, person of the belonging to both sex, and is also interested in the aims and objection of the Society/Association who is willing to abide by the Rules and Regulations (if the Society/Association shall along be the membership. If his Society/Association conduct and character are good.

- a) Members should be pay subscription regularly, if any members become defaulter he is liable to loose membership and power of voting. Membership could be restored to any person put in a request latter to the president.
- b) If any member or group of members went to separate themselves from the main or head quarter's Society/Association, he/she or they will not be entitled to any share in the assets or liabilities of the association.
- c) The office bearers, and other members of the governing body shall be elected by the General Body from among the members at the Annual Meeting of the General Body of the Association and shall have to hold office for a period of 2 years and may continue to be in office till he/she new committee or the governing body is elected and assume office on the last day of January.

4. Membership fee and Annual Subscription

- i) The subscription fee/Life Member Ship Fee Shall be **Rs. 1000/-** Every Member should subscribe **Rs.500/-** per annum, and Collect membership fee from the student **Rs.100/-** to the functioning of the Association.



- d) To appoint Auditor


8. Quorum:

d) **Vice PRESIDENT-III:-**


He/she shall assist the vice president-II in discharging his duties in the absence of the vice president-II he shall perform the duty of the vice president - II as entrusted by him/her.


e) **Vice PRESIDENT-IV:-**

j) Joint SECRETARY-IV : -


He/she has to do the work entrusted by the executive committee.
He/she has to assist the Joint Secretary-III in discharging his duties, in the absence of the Joint secretary-III; he can perform the duties of the Joint secretary-III.


k) Joint SECRETARY-V : -

12. Amendments: -




13. WINDING UP:-

In case the society has to be wound up the property and funds of the Society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institutions with similar aims and objects.

14. Income Tax Rules

- a. The Society will invest the funds in accordance with the provisions of the section 13(1) &(d) read with section 11(5) of the Income Tax Act,1961
- b. The accounts of the society will be maintained regularly and audited by the qualified auditor for every Financial year
- c. The Society is irrevocable
- d. The funds of the society would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees /persons defined in section 13(1) (c) of income tax act,1961
- e. In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institutions with similar aims and objects and enjoying exemption under 11 & 80(G) of the Income Tax Act,1961
- f. The benefit of the society would be available to the general public irrespective of caste, creed, sex, religion.
- g. The charitable activities should be confined to the territory of india only.
