At the outset, while welcoming the participants to the meeting, the Dev Edn Officer has explained through a presentation on the actions taken on the decisions taken in the last meeting of the SV VD Trust held on 04-10-2017

After thorough examination of the (i) students participation in the Yes+ program conducted in three degree colleges from 25th Oct to 09th Nov 2017, (ii) the feedback collected from the students on the above program and (iii) students registration for Second Semester of the program, the Trustees of SV VD Trust have unanimously agreed;

- (1) To pay the balance amount of Rs.5,17,259/- to the SSRDP Trust from SV VD Trust towards the Yes+ program conducted from 25th Oct to 09th Nov 2017 by the SSRDP trust in three colleges.
- (2) To conduct the Yes+ program in three degree college for the benefit of students who could not attend the program and who could not attend more than 20 hours of training during the program conducted from 25th Oct to 09th Nov 2017, as agreed by the SSRDP Trust to conduct without charging extra fee.
- (3) To conduct the second semester of the Skill Development program i.e training for development of English language Skills with the course content and duration as explained in the proposal of SSRDP Trust and MOU, and to entrust the program to the SSRDP Trust of the AOL Bangalore as per the terms agreed in the MOU.
- (4) To pay the Course Fee for the second semester of the Skill Development Training i.e Rs.1500/- plus GST per student for all students who register for the second semester by paying Rs.100/- as registration Fee. The amount of course fee will be paid from the funds of SVVD Trust to the SSRDP Trust in two installments i.e 50% of the course fee before starting of the training and remaining 50% at the end of the training program.

- (5) To request the JEO, TTD, Tirupathi to prepare the schedule, in consultation with SSRDP and College Principals, for conduct of the Yes+ program for those who could not attend the program for more than 20 hours and to conduct the II semester of the Skill Development Training in three degree colleges.
- (6) To decide the further course of action for conducting the further semesters of the Skill Development Training after reviewing the students response for the second semester.
- (7) To purchase the Indian Express English news paper with offer price i.e Rs.400/- per year for one paper by paying annual subscription in advance from SV VD Trust funds and supply @ one paper per room for all rooms in the hostels of three degree colleges of TTD.
- (8) To examine the subject of conducting the Skill Development Training to the students of SW & TW hostels after assessing the results of the program in TTD colleges.

The Trustee of SSRDP Trust Sri RN Merani has agreed to conduct the Yes+ program in three degree college for the benefit of students who could not attend the program and who could not attend more than 20 hours of training during the program conducted from 25th Oct to 9th Nov 2017 without charging extra fee.

**NOTE:**

1. The Sravanam Project was initially started with a purpose to identify the hearing impaired children at an early stage and to provide them necessary treatment to avoid permanent deafness to the hearing impaired children. This will enable them to integrate into the mainstream of schools vide reference 1<sup>st</sup> cited.
2. In the reference 2<sup>nd</sup> cited, the Hon'ble High Court as issued orders that, the petitioners are entitled to payment of Equivalent minimum time scale attached to the posts held by them. In the circumstances, there shall be interim direction to the respondents to pay the petitioners the minimum time scale of pay attached to the posts as long as the petitioners are continuing in service" Accordingly, the subject matter was placed before the finance committee in its meeting held on 22.10.2019 has recommended the following:

**"It is recommended to extend the equivalent Minimum Time Scale (EMTS) to the Sravanam Project Society members as per the interim directions of the Hon'ble High Court, subject outcome of the main petition by continuing the present system of paying them under a society mode. The interim court orders can be contested by engaging a suitable Senior Council."**

**"Since the success rate is very low and the expenditure is very high an expert panel has to be engaged immediately to**

study the purpose of the project and whether the objectives are achieved by means of present spending and whether the project can be streamlined by means of any other mechanism so that the purpose will be better served than the present mode.

3. There upon, the TTD Board has resolved to accept the recommendations of the Finance Committee in its Res.No..50 dt:23.10.2019 and orders issued vide Proc.Roc.No.C2/10850/Dy.E.O (Spl. Edn.)/Tpt/2018 dt:3.10.2019
4. Later the Audit department of TTD has informed that, the Minimum Time Scale to the staff of Sravanam Project Society as directed by the Hon'ble High Court can be extended only by adopting relevant time scale attached to the post included in G.O.Ms.No.1060 adopted by the TTD as per Govt. norms.
5. Accordingly, the then Dy.E.O (Spl. Edn.), TTD has proposed to adopt the pay scales equivalent to the posts sanctioned in Deaf & Dumb Schools maintained by TTD and included in G.O.Ms.No.1060. 5 Nos., common category posts sanctioned in TTD general establishment covered under G.O.Ms..No.1060 are adopted for outsourcing staff of Sravanam Project Society as per order of the HHC. 

6. Further, it is to submit that in the proposals submitted and resolved by the TTD Board vide Res.No.50 dt:23.10.2019 the EMTS (Sl.No.6) attached to the post of the Office Assistant (Rs.18400 - 55410 in RPS 2015) was inappropriately equated with the Junior Assistant of TTD Service Rules (G.O.Ms.No. 1060) instead of the post of Assistant /Shroff (Rs.15030-46060 in RPS 2015). If the scale of Office Assistant in Sravanam is equated with Junior Assistant in other Educational Institutions of TTD, it may end up in getting Audit Objections. Hence it is proposed to rectify the scale of the Office Assistant on par with the Minimum Time Scale of Rs.15030/- attached to the post of Asst / Shroff as per G.O.Ms.No.1060
7. In view of the above submissions, it is proposed to rectify the scale of the Office Assistant proposed and resolved earlier by TTD Board regarding the Minimum Time Scale from 18400/- (Jr. Asst., Scale) to Rs.15030/- i.e, that of (Asst./ Shroff scale) attached to the post in G.O.Ms.No.1060

**NOTE:**

1) Permission was accorded to implement the UGC Revised Pay Scale, 2016 w.e.f 01.01.2016 to the teaching staff who are drawing UGC pay scales 2006, vide GO. Ms. No. 14 HE (UE) Dept. dated 13.02.2019. It is further stated that the payment of arrears in the UGC revised pay scales, 2016 from 1.1.2016 to 31.3.2019 will be credited into GPF account of the respective teachers on receipt of reimbursement from Government and the revised salary in these scales will be paid in cash from 01.04.2019.

2) On the recommendations of the Finance Committee, the said GO was placed before the TTD Board to implement the UGC RPS 2016 to the eligible teaching staff working in TTD Educational Institutions. The Board vide resolution No. 120 dated 23.10.2019 has approved the proposals. Accordingly, orders were issued vide Proceedings Roc.No.TTD-80021(31)/76/2019-DEO-TTD dated 31.10.2019 for implementation of UGC RPS 2016.

3) As per the above orders, pay fixation proposals (forms with Service Registers) were sent to the Regional Joint Director, Collegiate Education, KADAPA, for verification and counter sign the above, as per the memo No. 01/UGC-PF/2018 dated 12.03.2019. But the proposals were rejected stating that they have not received any instructions from the Commissioner of Collegiate Education, Govt., of AP, Vijayawada, to take up the fixation work.

4) A letter dated 17.02.2020 was addressed to the Commissioner, Collegiate Education, Vijayawada with a request to clarify whether it is required to submit the proposal to the Regional Joint Director of Collegiate Education, Kadapa / Commissioner of Collegiate Education, AP., Vijayawada for fixation of pay under

UGC RPS 2016 in respect of the teaching staff of colleges functioning under the TTD as in the case of previous occasions (or) TTD can take up the task as per the guidelines issued in the GO. Ms. No. 14 HE(UE) Dept dated 13.02.2019.

5) In reply, the Special Commissioner, Collegiate Education, Govt., of AP, Vijayawada in the Proceedings Rc.No.03/UGC.PF/2020 dated 24.02.2020, had clarified that the Executive Officer / Management of the TTD Institutions can take up the work of Pay fixation of its employees whether it is in UGC or State pay Scales as no Grant in aid is being released from Government for more than a decade.

6) Hence, as per the clarification given by the Special Commissioner, Collegiate Education, Govt., of AP, Vijayawada, the pay fixation was effected to all the eligible teaching staff working in TTD Degree & Oriental Colleges from the month of July-2020. With regard to payment of arrears, the authorities had decided to get the specific expenditure sanction for the amount to be paid as arrears under UGC RPS 2016 and thereby instructed to place the matter before the TTD Board for its approval.

7) The statements of arrears payable to the eligible teaching staff, working in TTD Degree & Oriental colleges are as follows:

8) The financial implication towards payment of arrears w.e.f 01.01.2016 to 30.06.2020 to the eligible teaching staff working in TTD Degree & Oriental Colleges under UGC RPS 2016 will be around Rs. 9 crores. The GPF component is around Rs. 5 Crores and the cash component is around Rs. 4 crores.

9) On the proposals of the Secretary, Andhra Pradesh State Council of Higher Education, Vijayawada, vide his letter No. APSCH/UMS-1104-UGC-Arrears-Univs.-Govt./2020 dated 06.01.2020, the Government of Andhra Pradesh in its GO Rt. No. 16 Higher Education (U.E) Department dated 09.02.2021 has accorded administrative sanction to incur an amount of Rs. 503,00,00,000/- (



Rupees Five Hundred three Crores only) for distribution among the Universities, Commissioner for Collegiate Education and Commissioner of School Education towards payment of arrears of UGC Pay Scales of 2016 to the teachers working in the Universities and Degree Colleges offering B.A., B.Com, B.Sc., under Commissioner for collegiate Education and B.Ed., B.P.Ed., under Commissioner for School Education and also instructed all the Registrars of Universities, Special Commissioner Collegiate Education, Commissioner of School Education, Secretary, APSCH to take necessary action in the matter.

10) The Special Commissioner of Collegiate Education, Andhra Pradesh, Vijayawada, in his Proceedings Rc.No. 15 / Admn.III / 2020 dated 17.02.2021 has communicated the sanction orders to all the Drawing and Disbursing officers and requested them to take necessary further action in the matter.

11) The Addl. FA & CAO, TTD, Tirupati was requested to release the amount and include in the Revised Budget Estimates, for an amount of Rs. 9,00,00,000/- (Rupees Nine Crores only) in the financial year 2021-22, so as to make the arrear payments under UGC RPS 2016, vide letter Roc.No. EDN1/76/2019-DEO-TTD (Part-I) dated. 01.03.2021.

12) Hence, the subject matter is placed before the TTD Board for taking decision on payment of arrears around **Rs. 9,00,00,000/- (Rupees Nine Crores only)** to the eligible teaching staff under UGC RPS 2016, as per the GO. Ms. No. 14 HE (UE) Dept. dated 13.02.2019.



**NOTE:**

1. Sri S.Anabzhagaan, Vocational Instructor, S.V.Higher Secondary School, Vellore in his representation dt.21.05.2020 stated that he is going to retire on the AN of 31.05.2020 on attaining the age of 58 years as per the retirement orders communicated vide Proceedings Roc.No.TTD-30021(31)/86/2019/DEO-SEC, TTD Dt.22.11.2019. The Government of Tamil Nadu has increased the age of superannuation of Government Servants, Teachers (Aided Schools also) etc., from 58 years 59 years from 31.05.2020 vide G.O.Ms No.51, dt.07.05.2020. Hence, requested to permit him to work as Vocational Instructor continuously from 01.06.2020 to 31.05.2021 as per the new GO and to issue necessary orders in this regard.
2. In this regard it is to apprise that the S.V.Higher Secondary School, Vellore is fully aided school following the Rules and Regulations of the Board of Higher Secondary Education Tamil Nadu State. The School is sanctioned with 17 Teaching Posts and 14 Non- Teaching posts. The pay and allowances of the staff working in the sanctioned post of the said school are being drawn as per Pay Scales attached to the aided post of Secondary School Board of Tamil Nadu and the salaries are paid by Tamilnadu Government and the expenditure towards salaries is borne by T.N Government and there is no financial burden on TTD.
3. In this connection it is to submit that the Government of Tamil Nadu in its G.O.Ms.No.51, Personnel and Administration Reforms (S) Department, Dt.07.05.2020, has increased the age of superannuation of Government servants from 58 to 59 years and said that this will apply to those who are in regular as on date and due to retire on superannuation from 31.05.2020. Further it was ordered that this order is applicable to all teaching and non-

teaching staff working in aided educational institutions and employees of all Constitutions / Statutory Bodies, Public Sector Undertakings including all State Corporations, Local Bodies, Boards, Commissions, Societies etc.

4. The Government of Tamilnadu in its G.O.Ms.No.51, dated:07.05.2020 stated that this will apply to those who are in regular as on the date and due to retire on superannuation, on 31.05.2020. While the matter stood thus, this office issued retirement orders vide Proc.Roc.No.TTD-80021(31)/186/2019/DEO-SEC, dt:26.05.2020.

5. Further, as per the Service Rules communicated vide G.O.Ms No.1060, Revenue (Endowments-I), Dt.24.10.1989, the Rule 9 (i) is as follows:

"The Method of recruitment for appointment, qualifications and the age prescribed for various posts shall be as specified each post in Annexure-II to these rules.

Provided that in case of teaching staff of Educational Institutions affiliated to any of the University or any Government, the rules of such University or such Government as the case may be in respect of qualifications, age, method of recruitment, pay and allowances, vacation, leave salary travelling allowances and age of retirement shall apply".

6. The subject was placed before the Education Committee. The Committee recommended:

(i) To adopt the said GO extending the retirement age from 58 years to 59 years to the staff working as on date and due to retire on 31.05.2020 in the sanctioned post (aided Post) of S.V.Higher Secondary School, Vellore.

(ii) To permit Sri S. Anbazhagan, Vocational Instructor, S.V. Higher Secondary School, Vellore to continue his service from 01.06.2020 to 31.05.2021 as per the aforesaid G.O.

- 5) As per principles of the tender "the deciding factor will be the least rate payable by TTD for supply of vegetables and transportation charges". Under this aspects/provision with *reference* to the rate quoted by Sri Annadatha Farmer Producers Mutually Aided Co-operative Society Ltd., Cheldiganipalli, the least rates for supply of vegetables to be paid by calculating Rs.3.50Ps discount per Kg (or) 3.5% discount per Kg on lowest rates of Tirupati Rythu Bazar and Rythu Bazar, Chittoor on each and every category of vegetables supplied. On comparison of rate and percentage offered, the payment will be made to the least rate payable to the supplier.
- 6) The another Society i.e Rythu Mitra Seva Sangam, Pakala has quoted Rs.3.00 Price discount and 3.5% percentage discount which is not beneficial to TTD as per tender principle and offer of rate could not be acceptable as far as the payment factor involvement is concerned.
- 7) Both Sri Annadatha Farmer Producers Mutually Aided Co-operative Society Ltd., Cheldiganipalli and Rythu Mitra Seva Sangam, Pakala have not quoted transportation charges. Hence, payment of transportation charges does not arise.



**NOTE:**

1) The Govt. of A.P. in the reference 1<sup>st</sup> cited, consolidated the pension of pre-2016 pensioners / family pensioners of University / Govt. Degree colleges and Aided teaching staff of private degree colleges who have drawn the UGC scales of pay in 2006 and retired from service between 01-01-2006 and 31.12.2015. The revised consolidated pension / family pension shall come into force w.e.f., 01-01-2016. The arrears on the revised consolidated pension will be paid w.e.f. 01-04-2019. The arrears consequent to the consolidated pension for the period from 01-01-2016 to 31-03-2019 will be issued separately.

- 2) The Board of Trustees, TTD in the reference 2<sup>nd</sup> cited have resolved and approved to adopt the above G.O with the financial implication of Rs.5.00 Crore approximately. Necessary proceedings was issued in the 3<sup>rd</sup> cited.
- 3) Pursuant of the implementation of consolidated pension, the revised pay of the teachers who had been retired from TTD service for the period between 01-01-2006 to 31-12-2015 was claimed and paid from August-2020 onwards and the payment of revised pay for the period from April-2019 to July-2019 was kept pending which will be processed later after improving the financial position of the TTD due to COVID-19 as per the proceedings 4<sup>th</sup> cited.
- 4) Government of A.P. in their G.O. 5<sup>th</sup> cited an amount of Rs.503,00,00,000/-Crores towards payment of arrears of UGC pay scales 2016 and orders accorded of administrative sanction duly enclosing an annexure authorizing the amount allotted to the University / Dept. and issued guidelines while admitting the claims in proceedings in Roc.No.15 / Admn. III/2020, dt:17-02-2021.
- 5) In pursuance of the above G.O, sanction / Permission was already accorded for the payment of arrears consequent on consolidation of the pension 2016 to the teaching staff service pensioners / family pensioners, TTD w.e.f., 01-04-2019 onwards who have drawn the UGC scales of pay and retired from TTD service prior to 01-01-2016 as per the orders of the EO, TTD in the reference 6<sup>th</sup> cited.
- 6) In this connection, it is to submit that the payment of arrears during the period from 01-01-2016 to 31-03-2019 is due to the teaching staff of service pensioners / family pensioners consequent of the implementation of the UGC revised pay scales, 2016 w.e.f. 01-01-2016 as per the G.O. in the reference 7<sup>th</sup> cited. The payment of arrears for the above period was ordered to credit into GPF a/c of the respective teachers on receipt of the reimbursement from the Government and the revised salary in these scales will be paid in cash from 01-04-2019.
- 7) Kind attention is invited to the proposals of payment of UGC arrears to pensioners, and it is to submit that the retired teaching staff of service pensioners / family pensioners have no GPF a/c from their retirement in TTD. Hence, the financial implication towards the payment of arrears from 01-01-2016 to 31-03-2019 has to be paid by cash to the teaching staff of TTD colleges who have drawn UGC scales of pay in 2006 and retired from the TTD service between 01-01-2006 and 31-12-2015.
- 8) Thus, the financial implication towards payment of arrears from 01-01-2016 to 31-03-2019 for 276 teaching staff service pensioners and family pensioners comes to Rs.16,02,03,303 (Rupees Sixteen crore two lakh three thousand Three hundred and three only) (approximately).



9) The Addl. FA & CAO, TTD may be requested to release **the amount and include in the revised budget estimates for an amount of Rs.16 Crores in the financial year 2021-2022 so as to make the arrear payments under UGC RPS 2016. There is no budget provision made for this arrears to be paid in 2021-2022.**

10) The subject matter was submitted before the Finance Committee for its recommendations and there upon to the Board of Trustees, TTD for taking decision on the proposals.

### **Recruitment Process:**

- Applications are invited on-line for recruitment to the post of Lecturers in Govt Degree Colleges by Andhra Pradesh Public Service Commission (APPSC).
- The APPSC conducts Screening test in off-line mode in case applicants exceed 25,000 in number and the main examination in on-line mode for the candidates selected in screening test.
- Applicants must possess the qualification from a recognized University as detailed below:
  - 1) Good academic record with minimum of 55% or an equivalent Grade of B at the Masters Degree level in the relevant subject, obtained from the Universities recognized in India.
  - 2) NET/SLET shall remain the minimum eligibility condition for recruitment and appointment of Lecturers in Govt Degree Colleges.
  - 3) Candidates who are or have been awarded Ph.D degree in compliance of the University Grants Commission shall be exempted from the requirements of the minimum eligibility condition of NET/SLET to recruitments and appointment of Lecturers in Govt Degree Colleges.
- The selection of candidates for Appointment to the posts will be made in two stages:
  - Written Examination (Objective Type)
  - Oral Test in the form of Interview only for those qualified as per rules. The final selection of candidates for Appointment to the posts will be based on the Merit in the computer based examination and Oral test (Interview) marks put together to be held as per the scheme of examination.
- Only those candidates who qualify in the written examination by being ranked high will be called for interview in 1:2 ratio. The minimum qualifying marks in the examination for consideration of a candidate to the selection process in case of OC category is 40%, for BC category it is 35% and for SC, ST and PH categories it is 30% or as per the relevant rules. The minimum qualifying mark is relaxable in the case of SC/ST/BC/PH at the discretion of the Commission Applicants clearing the above procedure will be allotted posting as per the vacancies availability in the State.
- The candidates will be selected and allotted to Service/ Department as per their rank in the merit list and as per Zonal / Post preference opted by the applicant at the time of making application to the post online.
- The whole process is done with the help of Andhra Pradesh Public Service Commission (APPSC).

**Grievance Redressal Mechanism:**

- e) **Grievances Redressal Cell:** Grievances Redressal Cell is setup to resolve the grievances of employees. It consists of Principal, Vice-Principal, Co-ordinators and senior faculty members including women faculty members.
- f) **Anti-ragging Cell:** It resolves complaints received from the aggrieved parties.
